EXPLORING THE SPACE: THE NONPROFIT SECTOR

Defining the Space:

The nonprofit career space is diverse, encompassing roles in organizations dedicated to social change, public service, and policy influence. Instead of prioritizing profit, these organizations aim to create lasting societal impact. Nonprofits often collaborate with government agencies and hire a wide range of professionals, including executives, researchers, advocates, program staff, and grant managers. Temporary or consulting positions are also common, reflecting the sector's need for specialized skills and adaptability.

Frequently described as: Mission-Driven; Impact-Focused; Collaborative; Strategic; Community Oriented; Flexible; Fast-Paced

- Policy Analyst, Advisor, or Manager

New NIJ-funded Evaluation of Pennsylvania's 8th Edition Sentencing Guidelines and their Impacts on Racial and Ethnic Disparities

Dr. Clare Strange (Principal Investigator) and a team of researchers from Drexel University (Dr. Jordan Hyatt), Penn State University (Dr. Jeffrey Ulmer), and the Pennsylvania Commission on Sentencing (PCS) (Jordan Zvonkovich) are conducting a study entitled, 'A Statewide Mixed-methods Evaluation of Pennsylvania's 8th Edition Sentencing Guidelines and their Impacts on Racial and Ethnic Disparities in Sentencing Outcomes.' This project is a five-year process and outcome evaluation (2024–2028) with financial support from the National Institute of Justice (NIJ) W.E.B. Du Bois Program of Research on Reducing Racial and Ethnic Disparities in the Justice System.

The 8th edition of Pennsylvania's sentencing guidelines represents a sweeping and meaningful revision of previous editions. Over the last decade, PCS staff and members of the Commission have sought the expertise of researchers, practitioners, policymakers, and the public (including advocates and incarcerated individuals) to inform the proposed revisions. At the core of many discussions were the two dimensions of the basic sentencing matrix—offense gravity score (OGS, i.e., the severity of the current offense) and prior record score (PRS, i.e., a quantitative summation of criminal history)—which are used to calculate the standard range recommendation. The resulting revisions to OGS and PRS, among others, were intended to produce more specific, fair, and proportionate sentences. Most relevant to the

current study, the 8th edition, was specifically designed to decrease the impact of the accumulation of criminal history on sentencing to reduce racial and ethnic disparities therein.


This study seeks to address two overarching questions: 1) did the 8th edition succeed in reducing racial and ethnic disparities in sentencing, and 2) how were the various components of the 8th edition developed? When it comes to policy evaluation, many assessments downplay the importance processes and implementation in favor of outcomes and impact. To accommodate for this gap, this project is rooted in implementation science frameworks and focuses heavily on the events during the ten years preceding the 2024 adoption of the 8th edition.

In service of these questions, qualitative and quantitative data are being collected from three sources: 1) secondary documentation (e.g., reports, legislation, recorded presentations, Commission meetings, and public hearings), 2) semi-structured interviews with subject matter experts (e.g., academics, PCS staff), policymakers (e.g., legislators, Commission members), and practitioners (e.g., judges, prosecutors, attorneys, court administrators), and 3) statewide administrative sentencing event data.

The evaluation aims to produce rich and transferable knowledge for other jurisdictions seeking to revise their sentencing policies and reduce disparities. The level of insight into the policy reform process that this requires is not possible without the meaningful inclusion of project partners like PCS staff and current and former Commission members, whose input informs many aspects of the study (e.g., interview topics, sampling strategy, potential outcomes, the design and content of practitioner-facing deliverables) and helps to ensure that the evaluation has a positive and long-term impact on sentencing disparities in and beyond Pennsylvania. The published results of the process and outcome evaluations can be anticipated in 2026 and 2028, respectively.
